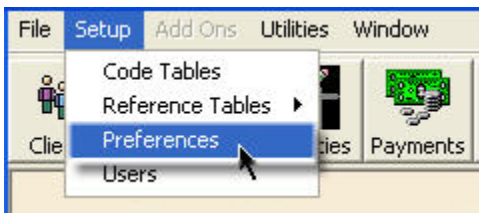

## Highlights:

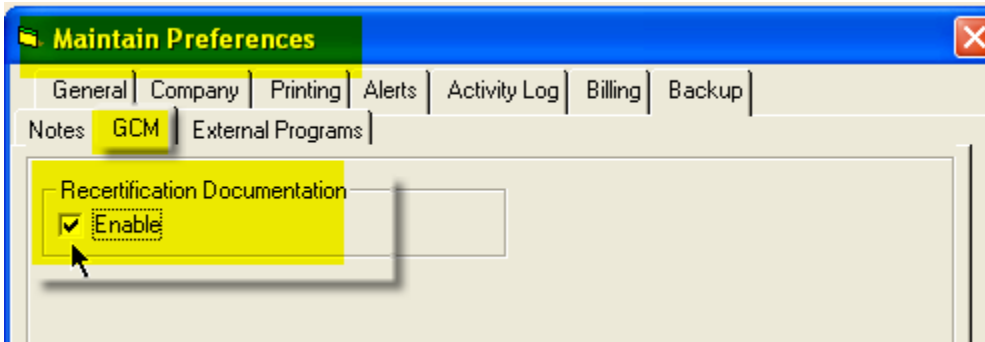
- The ability to create a “peer review” report for the GCM Recertification requirements using clients services and activities time to record your required documentation for GCM review.

- You can, seamlessly provide dates, duration in hours and minutes and narrative data for GCM Reports submission.

## Enable GCM Recertification feature

Click **Setup** – Select - **Preferences**



Click – **GCM** tab  
Check “**Enable**”



Click **Save** button – **Save Complete** – **Close** (Pressing the **Close** button automatically saves setting)

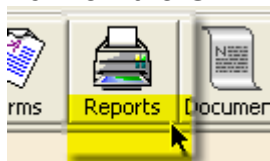

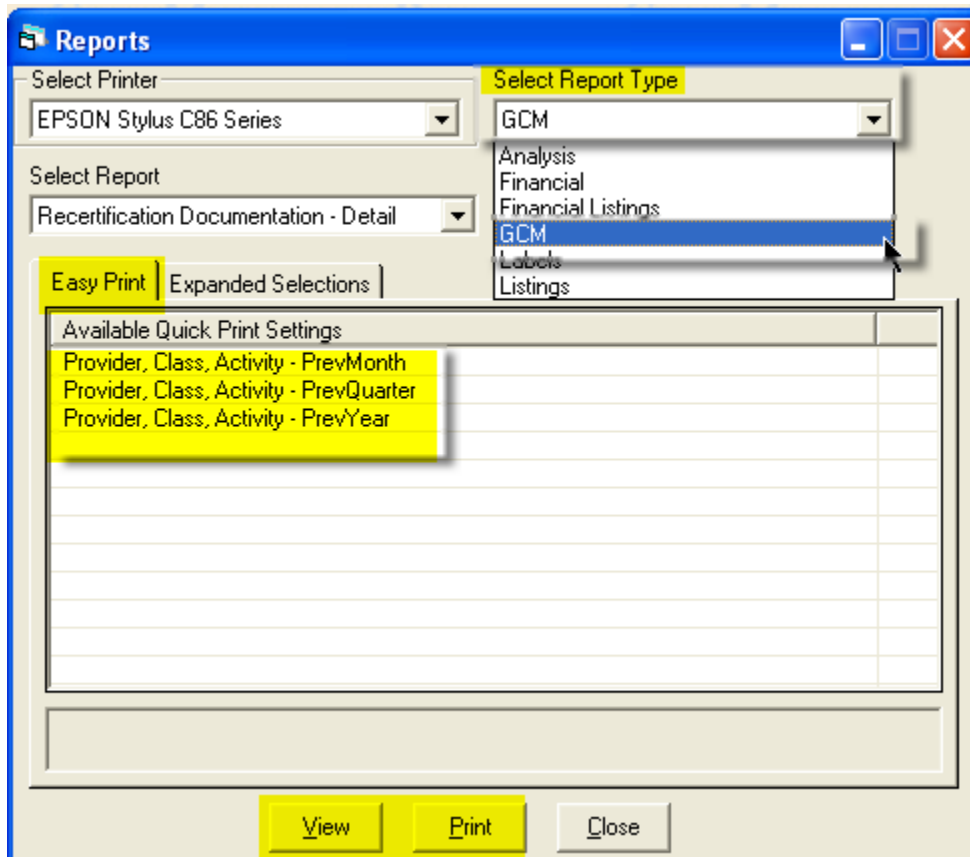
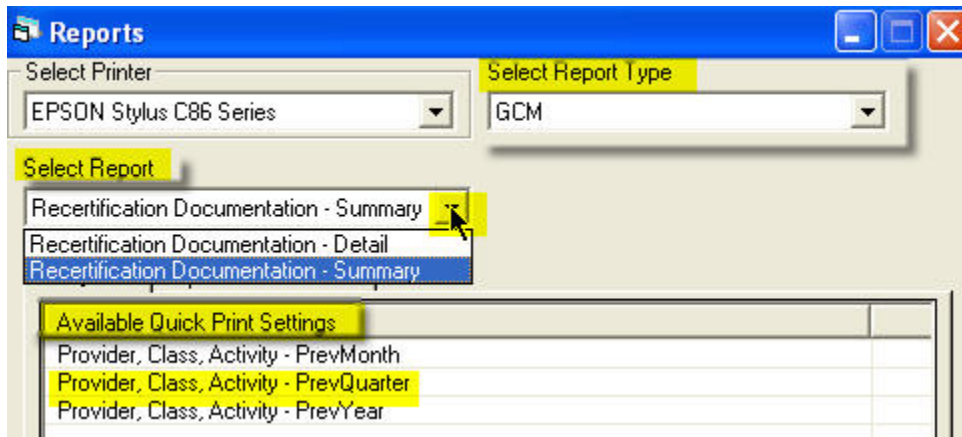
